Dear Council Member, We are writing you in response to your inquiry as we are completing the process of renewal for our unenclosed sidewalk café license. # 1385339

RE: Red Rooster Harlem LLC, 310 Lenox Avenue NY, NY 10027

Since our initial permit was approved and issued, we have organized our sidewalk café soundly within the parameters of the NYC DCA approved plan, which is 15 by 26 feet. There is no impediment anywhere within our site. Our sidewalk café does not block any entrances, bus stops or pedestrian walkways. Concurrent with the mandates of this process we sent notarized letters via registered mail to each of the required civic entities as well as all of our neighbors in the prescribed adjacent vicinity announcing the renewal. All items on the DCA renewal application checklist were sent in with our packet of documents and verified receipt by DCA staff at this point.
