and welcome. My name is Karen Koslowitz, and I am the Chairperson of the State and Federal Legislation Committee. Today, we will be considering two Sate Legislative Resolutions and two Mayor's Messages. First I would like to introduce the members of the Committee that are present at this time. Council Member Kallos, Council Member Maisel, Council Member Dickens, and Council Member Reynoso.

This afternoon, the Committee will be voting on two State Legislative Resolutions. The first being considered today would require the FDNY to provide all Fire Officers with at least 40 hours of field training and classroom instruction in the Building and Construction Codes, and local ordinances, and an additional 40 hours of field and classroom instruction in the Fire Code. Emphasis will be on the inspection duties of Fire Officers and any relevant changes to these duties as a result of the new Fire and Building Codes that took effect since July 2008.

The second State Legislative Resolution being heard today would support the passage of Senate Bill 6115 and Assembly Bill 8386, under current State

Law, which is set to sunset on December 31st, 2014.

New York City is authorized to install 150 red light cameras at one time. This proposed legislation would remove all conditions, and would authorize New York

City to install right light cameras as it deems fit.

The Committee will also be considering two Mayor's Messages. The first Mayor's Message being heard today supports the passage of S.7703 and A.9834, which would extend New York City authority to install and use up to 150 red light cameras. The current authority granted by the State is set to sunset on December 31, 2014. This proposed legislation would extend the sunset date to December 31, 2019.

Lastly, the Committee will consider a Mayor's Message, which supports the passage of A.9731, which seeks to amend the Vehicle and Traffic Law in the relation -- in the relation to speed limits. This bill would give New York City the authority to have a citywide speed limit of 20 miles per hour. Moreover, the bill would permit the City to make a written determination that traffic calming devices were not feasible at set locations. And could then have the limit at that location to be as

BILL LINDAUER: My name is Bill Lindauer. I drove a taxi for some 30 years in New York City. I'm a proud member of the New York Taxi Workers Alliance, which represents Yellow Cab drivers in New York City, and is part of the AFL-CIO. Our Executive Director Bhairavi Desai is a member of the Executive Council of the AFL-CIO. We all are for safety. Statistics show that cab drivers are the safest drivers in New York. I know we're targeted by the cops, and by snide remarks by the media and maybe some other people, who I won't mention. statistics don't lie in this case. We are the safest. We are New York's safest. I would love that to be the decal on every cab in New York as New York's Finest is on the police cars, and Bravest is on fire engines, et cetera. My point is...

BILL LINDAUER: Yes, I think the bill should be amended because it's discriminatory, and could subject the City to legal action against the City because you're singling out cab drivers. the legislation, the Taxi and Limousine Commission could give points for red light violations. Regular motorists won't get any points. So many drivers with families who have their licenses suspended for nothing. Because if the yellow lights are like this, I don't know if they barely meet the Federal Requirement Minimum of three seconds. It suddenly turns yellow, you either slam on the brakes or you go through. And when you go through, it could turn red. So you're damned if you do. Damned if you don't but to single out Yellow Cab drivers to make them scapegoats is unconscionable, and I think the bill should be amended to not permit the TLC to punish cab drivers while other motorists go free willingly.

CHAIRPERSON KOSLOWITZ: I think that it's a surprise to all motorists, and I just want to say

to clarify the Mayor's message regarding speed limit
would permit the city to reduce its citywide speed
limits as low as 25 miles per hour.

5 BILL LINDAUER: That we could live with, 6 yes.

CHAIRPERSON KOSLOWITZ: I don't... Well, that's what this bill is about.

BILL LINDAUER: It's just the camera things and the points that the TLC likes to subject cab drivers to. Other motorists pay fifty bucks and they're scott free. TLC wants to impose terrible fines; wants to levy points so drivers cannot make a living. Have their licenses suspended for nothing, and then they drive a hundred times more than any regular motorist. This is just totally unfair, and I find it's unconscionable, and this supposed to be a labor-friendly city. Not in this case.

CHAIRPERSON KOSLOWITZ: Okay. Council Member Maisel.

COUNCIL MEMBER MAISEL: You recognize that the only people who are allowed to drive a cab are the person who is licensed to drive that cab?

BILL LINDAUER: Of course.

BILL LINDAUER: Oh, aren't we the lucky ones, huh? [laughs]

COUNCIL MEMBER MAISEL: Well, but that's

-- that's -- but that's the rationale -- that's the

rationale since it's quite clear that if a Yellow Cab

is violating the restrictions, we know that it's the

Yellow Cab driver who's licensed and that's why they

get the points. So I don't know if there's anything

unconstitutional about that or illegal about that.

BILL LINDAUER: Well, we might find out in court one day. [laughs]
