SPEAKER MARK-VIVERITO: Thank you Madame
Public Advocate and thank you to all my colleagues;
it's 10:00 in the morning, very rare that we do meet
at an hour like this one, so I wanna just first say
good morning to all. I would also just wanna, since
we obviously last met and we are in recess and coming
from recess that we have lost an incredible human
being in Ruby Dee, so I wanted to take a moment to
honor and remember her; if people could stand for one
second so we take a moment to honor artist,
screenwriter, journalist, activist, and humanitarian,

2 Ruby Dee, who is best known for co-starring in films
3 like *Raisin in the Sun*, from 1961 and *American*
4 *Gangster*, from 2007, for which she was nominated for
5 an Academy Award for best supporting actress.
6 Obviously no words can be enough to really talk and
7 express her impact; she passed away a week ago today,
8 on June 11. Following her passing, President Obama
9 remarked that throughout her remarkable performances,
10 Ruby paved the way for generations of black actors
11 and actresses and inspired African American women
12 across our country, and we know that she will be
13 incredibly missed, so just wanted to take a moment of
14 silence as we remember her.

16 SPEAKER MARK-VIVERITO: Thank you, my
17 colleagues.

18 So we're here today -- a quick meeting,
19 hopefully -- to vote on three home rule messages that
20 will authorize and urge Albany to pass State
21 legislation relating to New York City issues before
22 the end of their legislative session.

23 Senate Bill 7892 and Assembly Bill 10144
24 would authorize the establishment of a citywide 25-
25 mile-per-hour speed limit. A few weeks ago we passed

2 a broad package of local laws to improve traffic
3 safety, but in order to take this next vital step of
4 establishing a citywide limit of 25 miles per hour,
5 we need State authorization to do so and this home
6 rule message will request just that. I also wanna
7 recognize, I know that we do have Amy Cohen Eckstein
8 who is here with us today who lost her son, Sammy
9 Cohen Eckstein; she's been an incredible activist and
10 advocate, going to Albany many times to encourage
11 that this legislation be passed; she's been non-stop
12 on this, so I do wanna recognize and thank her for
13 being here with us today.

14 Our next home rule message authorizes and
15 urges the passage of Senate Bill 7849-A and Assembly
16 Bill 10021-B, which would allow New York City to
17 expand joint bidding to public work projects across
18 the five boroughs. Allowing joint bidding on
19 contracts will facilitate the timely, cost-effective
20 and convenient completion of public work projects
21 involving private utility work.

22 And the final home rule message
23 authorizes and urges the passage of Preconsidered
24 State Legislation Resolution S.7664 and A.9059, which
25 would amend the New York City administrative code to

reflect a change in union representative for pilot and marine engineers in the FDNY pension fund chapter two. This change in the administrative code has become necessary because pilot and marine engineers are as of recently represented by the United Firefighter Association and as such, should be represented through UFA on the pension fund board.

Those are the three home rules that we will be voting on today and that covers our business here today and thus covers communication from the Speaker.
