Dear Members of the New York City Council,

We agree with the statement made by Council Member Rose on the inclusion of immigration as a topic to be discussed at the U.S. Africa Leaders Summit. According to the most recent census, foreign-born African immigrants represent over 1.6 million individuals residing in the United States. Moreover, the U.S. is the destination for 59% of Nigeria's high-skilled immigrants, along with 47% of those from Ghana and 29% from Kenya. In New York State alone, there is a population of 171,788 African immigrants, with 158,878 of those residing within New York City. These exact numbers though are highly debated with both African immigrant groups and former census workers claiming that in reality the numbers are significantly higher.

Dually noted, African immigrants are the most highly educated immigrant group, with 52.8% possessing a college degree, and 16.6% possessing graduate or professional degrees.

Even with these impressive statistics though, African immigrants make significantly less money on average per year than other immigrant groups possessing comparable educational merits, and are deported at alarmingly high rates.

We urge thus the passing of this resolution, to help give voice to those long-silenced African immigrant voices and bring justice to where justice is due.

Americans of African Immigrant heritage and our friends and allies; stand in solidarity in asking that Immigration Reform be on the agenda of your recently announced US-Africa Leaders Summit, slated for August 5 and 6 2014 and which will bring 47 African Presidents into Washington, DC.

Why should Immigration Reform and Diaspora Affairs be on the US-Africa Leaders Summit Agenda?

### 1.) U. S. based African Immigrants Contribute Significantly in USA:

Per US Census, African immigrants are not only the most educated immigrants when upon arrival into the United States; their first and second generation offspring are also the most educated Americans! On May 3rd in 2013, President Obama was in Mexico and in his speech discussing the relations of USA and Mexico, President Obama talked about the contributions Mexicans who migrated to the USA have made and why immigration reform is critical for **Mexico** and USA.

On March 14th 2014, The Irish Prime Minister of **Ireland** to the White House and immigration was part of the agenda and as the Irish PM puts it "We've got 50,000 (Irish immigrants) here in America, undocumented. Please join us in sending a letter to President Obama urging him to add comprehensive immigration reform to the agenda of the U.S.- Africa Leaders Summit.

In just a few months, President Obama will convene this first-ever, historic event. With 47 nations invited, this is an important opportunity to develop better relationships, discuss pressing issues, and to coordinate policy priorities.

However, when the conference was announced a few months ago, one important issue was not prioritized: immigration reform. We believe that this is an unfortunate oversight. Foreign-born African immigrants represent more than 1.6 million individuals residing in the United States, and the current immigration system has serious consequences for these individuals and their families. From family visa backlogs to our current deportation policies, comprehensive immigration reform will have a positive impact on this diverse community.

Many of the President's previous meetings with foreign leaders have featured a discussion of comprehensive immigration reform. We believe that prioritizing this same topic at the upcoming summit will highlight the need for congressional action across a wide number of constituencies.

Dear President Obama,

We would like to applaud you for taking the step to host the U.S. – Africa Leaders' Summit in Washington, D.C. on August 5 and 6, 2014. Strengthening the partnership between Africa and the United States is of the utmost importance to the future prosperity and security of our peoples. The proactive steps your Administration continues to take in the name of cooperation and mutual development deserves the full support of Americans and their elected officials in Congress.

This summit is an important opportunity to bring diverse constituencies together to discuss policy issues and to better develop ties between the United States and the 47 African nations invited to the conference. Unfortunately, we have been saddened to learn that the summit does not intend to spend significant time focusing on an issue that we believe is vital to our policies in Africa: immigration reform. We believe that inclusion of this topic for discussion at the summit will strengthen the ties between all the parties involved, and will help bring to light the need for comprehensive immigration reform across a wide number of constituencies.

According to the most recent census, foreign-born African immigrants represent over 1.6 million individuals residing in the United States. Throughout our history, immigrants from Africa have played an important role in revitalizing neighborhoods, starting small businesses, and improving local economies. The African community is an indispensable element of American culture and society, and continues to contribute to the prosperity of our nation.

However, our current immigration policies have had a negative effect on immigrants from African nations. Family immigrant visa backlogs, problems in asylum and refugee processes, student visa issues, and our ongoing deportation policies have created great difficulties for African immigrant communities. These concerns have serious financial and familial consequences for all involved, whether here in the United States or in the countries invited to the conference.

Many of your previous meetings with leaders of other nations have included a discussion of the need for comprehensive immigration reform. We believe that such a discussion at the U.S. - Africa Leaders' Summit will help better coordinate policies and improve relationships between all of the parties involved. We urge you to include and prioritize the need for comprehensive immigration reform at the upcoming summit.

We appreciate your consideration of our request, and sincerely hope that your administration will allow for a sincere conversation regarding immigration reform during the upcoming summit.

- 1. African immigrant challenges like the possibility of the elimination of the Diversity Visa lottery within the current immigration reform bill.
- 2. Other challenges Africans face are the disproportionately low numbers of work permits for internships and part tine work by our international students from Africa.
- 3. Disproportionately low percentages of Africans on work visas such as J1 (temp work visas), H1B visas etc.
- 4. African immigrants and Diaspora hardly engages/meet with President Obama on US African policies and with visiting African foreign leaders.
- 5. Our contributions such as remittances into the African continent and sweat equity into the diaspora such as African immigrant medical missions back into Africa etc.



Figure 4: African Foreign-Born Population by Citizenship, 2010





# Nearly half of African immigrants are naturalized U.S. citizens.

46.1% of African immigrants were naturalized U.S. citizens in 2010, compared to 43.7% of the foreign-born population as a whole {Figure 4}.


Figure 8: Increase in African Foreign-Born Populations in Top-Five States, 2000-2010


# More than one-third of African immigrants work in professional jobs.

37.7% of employed African immigrants age 16 and over worked in management, business, science, and arts occupations in 2010 (Figure 13).

One-quarter (24.8%) of employed African immigrants age 16 and over worked in service occupations in 2010, while one-fifth (19.8%) worked in sales and office occupations {Figure 13}.

#### Two-fifths of African immigrants have a bachelor's degree or more education.

Just under one-fifth (16.1%) of African immigrants age 25 and older had a graduate degree (in addition to a bachelor's degree) in 2010. In comparison, 10.4% of the U.S. population as a whole age 25 and over had a graduate degree in 2010 {Figure 12}.

Nearly one-quarter (24.2%) of African immigrants age 25 and older had a bachelor's degree only in 2010. In comparison, 17.7% of the U.S. population as a whole age 25 and over had a bachelor's degree only in 2010 (Figure 12).
