Please accept this letter as confirmation that as per our agreement for the sidewalk café application for 4 tables and 8 chairs, we will:

- Only our own customers will use the 4 tables and 8 chairs we are permitted. We will
  police this to be sure
- We will clean in and around the tables periodically during the day
- Between the hours of 8 9am, we will not put up the guards that separate the tables from the sidewalk cafe according to the plan approved by the NYC Department of Consumer Affairs.
- We will, at all times, set up the café according to the approved plans.
  - o The tables will be placed against the building
  - We will have a three foot waiter aisle, located between the guards and the tables, which is always maintained when the guards are up.
  - o The ice cream machine will be removed from the East 87th Street doorway
