CHAIR JOHNSON: Good morning, I'm Council
Member Corey Johnson, Chair of the Council's
Committee on Health. Prior prior to the budget
hearing this morning we are voting on proposed
introduction #1068A, by bill that would prohibit the
use of smokeless tobacco at baseball and other sports
stadiums, arenas and recreational areas. Smokeless
tobacco such as chewing tobacco and snuff is not
safe. These products are addictive and cause cancer
as well as, as well as other serious health problems.
When athletes who are role models to children are
regularly shown on TV with a wad of chewing tobacco
in their cheek that sends a harmful message that
smokeless tobacco is fun and socially acceptable.
The effect of the bad example set by this behavior is
clear. Smokeless tobacco used by young people is
disproportionally concentrated among athletes.
Boston, San Francisco and Los Angeles have all banded
smokeless tobacco at ball parks and we should do the
same here in New York by passing this legislation.
Once it is passed by the Council it is my hope that
the Major moves quickly to sign it in time for it to
go in affect by opening day which I believe is April
