Rosanna Vargas Opening Statement

I want to thank everyone for coming this morning and the Committee on Rules, Privileges and Election for holding this important hearing to consider my nomination to serve as the Bronx Democratic Commissioner of the Board of Elections.

As this Committee is aware, I was born and raised in the Bronx. I'm a practicing attorney in Akerman's New York law office. I'm an associate in the litigation department and my focus is on commercial litigation in state and federal court, mediations and arbitrations. I believe that my experience as a lawyer and the analytical skills that comprise much of practice will be an asset in identifying the issues and challenges of the Board of Election.

I am an active member of the Dominican Bar Association, Puerto Rican Bar Association, Hispanic National Bar Association and Latinas Organizing Latinas in Action. I'm also a member of the Law Committee of the Bronx Democratic County Committee which is being led by counsel to county. The law committee will focus on the needs of the community, such as youth seminars and events to assist in college application and personal statement, introduction to LSAT, mock job interviews and resume reviews, tailored to the community and youth involvement. I am also part of Akerman's internal network of Women's Initiative Network where one of the components is the community engagement program. Akerman also works alongside of the Court Appointed Special Advocate (CASA) Association program to promote volunteer advocacy for abused and neglected children in the foster care system.

I am committed and personally vested in the Bronx and in the State of New York. I believe that I'm able to protect each citizen's fundamental right to have their voices heard and counted through the electoral process. My goal is to ensure that the Bronx community voice is heard by ensuring their access to the ballots. I am confident that I am qualified for this position and that I am prepared to serve as Bronx Democratic Commissioner at the Board of Elections and I hope you will appoint me. I look forward to working with the Board and all the other Commissioners.

I have been in public service for over 30 years, whether in full time government positions or by serving the City and State as I have for the past 8 years as a member of the MTA, a significant governmental entity impacting the lives of millions of New Yorkers.

I am a native of New York City and began my career in government, working in the Manhattan Borough President's office. In 1982, when Mario Cuomo was elected governor, he asked me to join his administration, where I worked throughout his 12 year tenure in several positions and was appointed the Chairman of the Unemployment Insurance Appeal Board at the end of his administration. I served on that board until I joined the staff of former Bronx Borough President, Fernando Ferrer, whom I served with for four years as one of his chief assistants until he left office in 2002.

I spent the next year managing the campaign of Carl McCall in his effort to defeat Governor George Pataki. At the conclusion of that effort I went into the private practice of law where I have spent the past 14years doing primarily criminal defense work, with a significant part of my practice devoted to indigent defendants.

The common thread between all of my endeavors has been a commitment to social justice and reform, and a desire to make government work for all of the residents of our City and our State.

My tenure in government, including the MTA, has been defined by my independent spirit, obliged to seek ways for the government to work in a transparent way for all of our residents, so that everybody can share in the opportunities available, particularly in education, housing and employment. I know that a good City job is a pathway to a better life. I will give each applicant the serious consideration to which they are entitled. If the City Council approves my appointment, I pledge to do everything the law permits to ensure that those whose appeals are before me are treated in as timely, fairly and in as transparent manner as the law permits.
