2 CHAIRPERSON VAN BRAMER: We are ready. 3 Good afternoon, everyone. My name is Jimmy Van 4 Bramer and I'm proud to be the Majority Leader, and I 5 am sitting in for Council Member Johnson, the Chair 6 of our Health Committee as Acting Chair. Today, the committee will vote on Intro No. 1194. This bill 8 would make a clarification to Local Law 57 of 2016, a 9 law we passed in April to require defibrillators of 10 youth baseball games and practices on city-owned 11 baseball fields. Local Law 57 requires that the city 12 provide defibrillators to the leagues, but Intro No. 13 1194 would clarify that if the city fails to provide 14 the defibrillators, at some point in the future the 15 leagues will not be obligated to buy them. Requiring 16 leagues to pay for the required defibrillators could 17 cause financial hardship for some leagues, and this 18 bill clarifies the city's responsibility. As always, 19 we thank Minority Leader Matteo, now the prime 20 sponsor of this bill who has been a leader on this 21 issue. And before I call our vote, I'll recognize 2.2 our colleagues who are there, Council Member Mendez, 23 Council Member Koo, Council Member Vacca and Council 24 Member Barron, and with that, I ask for the clerk to 25 call the roll.
