# Int. 247-A - Local Law 46

A Local Law to amend the administrative code of the city of New York, in relation to criminal and civil penalties for the performance of unlicensed electrical work.

# Int. 267-A - Local Law 47

A Local Law to amend the administrative code of the city of New York, in relation to establishing a pilot program for reserving parking spaces in municipal parking facilities.

## Int. 748-B - Local Law 48

A Local Law to amend the New York city charter, in relation to drug strategy.

#### Int. 820-A – Local Law 49

A Local Law to amend the administrative code of the city of New York, in relation to voluntary recycling incentive pilot programs in public housing.

### Int. 873-A - Local Law 50

A Local Law to amend the administrative code of the city of New York, in relation to establishing a carsharing parking pilot program.

#### Int. 882-A – Local Law 51

A Local Law amend the New York city charter, in relation to requiring the installation of induction loops systems for certain capital projects paid in whole or in part from the city treasury and requiring the publication of public locations where such systems are available.

### Int. 1071-A - Local Law 52

A Local Law in relation to requiring the department of transportation to study private streets.



#### Int. 1161-A – Local Law 53

A Local Law to amend the administrative code of the city of New York, in relation to reporting on HPV vaccination rates.

### Int. 1162-A - Local Law 54

A Local Law to amend the administrative code of the city of New York, in relation to reporting on the use of contraceptive methods.

# <u>Int. 1172-A – Local Law 55</u>

A Local Law to amend the administrative code of the city of New York, in relation to requiring the department of health and mental hygiene to issue an annual report on maternal mortality.

#### Int. 1198-A - Local Law 56

A Local Law to amend the administrative code of the city of New York, in relation to flood mitigation in southeast Queens.

### Int. 1280-B - Local Law 57

A Local Law to amend the administrative code of the city of New York, in relation to requiring the police department to share collision reports digitally.

#### Int. 1474-A – Local Law 58

A Local Law to amend the administrative code of the city of New York, in relation to taxicab licenses.

## Int. 1475-A – Local Law 59

A Local Law to amend the administrative code of the city of New York, in relation to the definition of ownership and use of a licensed taxicab, and to repeal subdivision i of section 19-504 of the administrative code of the city of New York, relating to the ratio of the number of taxicab licenses.
