6	apologies for the delay. My name is David
7	Greenfield; I am the Councilman from the 44th Council
8	District in Brooklyn; I'm privileged to serve as the
9	chair of the Land Use Committee. I want to welcome
10	my colleagues who are members of the Committee and
11	who have joined with us today Council Member
12	Palma; Council Member Mealy; Council Member Lander;
13	Council Member Richards; Council Member Cohen;
14	Council Member Kallos; Council Member Reynoso;
15	Council Member Treyger; Council Member Grodenchik;
16	and Chair Salamanca.
17	I wanna thank Chair Salamanca, Chair
18	Richards, and Chair Koo for their outstanding work or
19	our Land Use Subcommittees; today we'll be voting on
20	resolutions for six applications that were
21	recommended by the Subcommittees.
22	We'll be voting to approve LU 789, the
23	Khe-Yo sidewalk café application in Council Member
24	Chin's district. Council Member Chin supports
25	approval, as this applicant made commitment to limit

2 the hours of the café and limit noise generated by 3 the customers.

We'll be voting to approve LU 784, the
449 Broadway special permit application, also in
Council Member Chin's district. This application
would allow for retail use in portions of the ground
floor and the cellar of an existing five-story
building. Council Member Chin supports approval
after the applicant submitted a letter committed to
conducting outreach to find a culturally-related
tenant and to consult with the Council Member's
office prior to choosing any tenant that would use
the space for an eating or drinking establishment.

We'll be voting to approve, with modification, LU 787 and 788, the Myrtle Avenue Rezoning in Council Member Levin's district. This application for a zoning map amendment and text amendment will facilitate the development of an eight-story, 66-unit mixed-use development; 25 percent of the floor reserved for the affordable housing through MIH Option 1. We are going to take modifications of this application to remove MIH Option 2 from the rezoning area and to change the proposed R6A zoning district outside of the

development site to an R6D [sic] district to more closely match the existing building. Council Member

Levin supports approval with these modifications.

We're voting to approve Preconsidered

Land Use application for the landmark designation of
the Old Saint James Episcopal Church in Council

Member Dromm's district. Built between 1735 and

1736, the Old Saint James Episcopal Church has a
significant association with the early colonial

settlement of Queens and with the mission activity of
the Church of England and the American colonies, a
remarkable colonial era mission church that retains
its early 18th century rectangular box-like form,
wood shingle siding, round arched windows, and heavy
timber framing; it is New York City's oldest Church
of England building and the City's second-oldest
religious building that is still standing. Council

Member Dromm supports approval of this designation.

We'll be voting to approve LU 791, an acquisition and site selection application submitted by the New York City Office of Emergency Management and Department of Administrative Services that seeks to expand an existing OEM warehouse located at 930 Flushing Avenue in Council Member Reynoso's district.

This application will commit the warehouse to increase from 96,600 square feet to 304,000 square feet; the additional space for this application is needed for the storage of additional emergency equipment and supplies to fully build up and back up emergency operations center. Council Member Reynoso is in support of the acquisition.

Finally, we'll be voting to approve
Proposed Introduction No. 1692-A, a local law to
amend the Administrative Code of the City of New York
in relation to technical corrections to Local Law 116
for the year 2017. The bill would make corrections
to Administrative Code Section 25-114 as added by
Local Law 116 of 2017. It would amend the
construction code by classifying violations of
conditions, restrictions and requirements relating to
privately owned public spaces as major violations and
would establish a minimum \$4,000 penalty for a first
violation and a minimum \$10,000 penalty for a
subsequent violation.

We'll now move on to vote on these five applications and a local law before moving on to a vote on our last application, and we are voting to approve Proposed Introduction No. 1692-A. On the

Land Use applications we're voting in accordance with the recommendation of the subcommittees and with the support of local Council Members to approve LU 784, 789, 791 and a preconsidered landmark designation and approve LU 787 and 788 with the modifications that I just described.

So to be clear, clerk, we're gonna have two votes; yes? [background comment] [pause] Okay, revise that; we are in fact going to have one vote on all of the items, and I would like to turn it over to Council Member Kallos to speak of Intro 1692-A, which he is the prime sponsor and I'm pleased to be the cosponsor along with him.

COUNCIL MEMBER KALLOS: Just wanna thank
Chair Greenfield for adding a new light to POPS.

Some might think POPS are just how you say soda in
Buffalo and Western New York and other parts of the
country, but here -- [background comment] and
Detroit, but here in New York City POPS are privately
owned public spaces and they are often honored breach
-- Council Member Greenfield held a hearing; our
Comptroller held an audit; we have been all working
together on legislation, and grateful to be working
with our chair on this and hopefully moving forward

we'll actually see signage in all of the POPS that actually shows what we're supposed to have there and we'll actually be able to use them, regardless of what a security person may say and there will actually be fines for when people don't follow the rules, which should have a huge impact when we see \$4,000 for the first offense and \$10,000 or more on second and additional offenses. Thank you to the chair.

CHAIRPERSON GREENFIELD: Absolutely.

Thank you, Council Member Kallos. And just to expand on that, there are approximately 3.2 million square feet of public space in New York City; it's known as privately owned public space, where we as the City agreed to give developers more ability to build in return for providing these privately owned public spaces. Some of them are easily accessible; you'll walk down the street, you'll see a building, you'll see some seats next to it and you know that's a public space that is privately owned; others, unfortunately, are not easily accessible and so we've held hearings and we've passed legislation to enforce it, to bring signage; to actually have folks come and inspect it as well and I'm proud to have worked very

closely with Council Member Kallos on this particular legislation Council Member Kallos is sponsoring and I'm co-sponsoring, which would increase the penalties for violations for not allowing the public to access these public spaces. So I wanna thank Council Member Kallos for being a partner with me for the last two years on the POPS-related legislation; are very pleased that we're able to get this wrapped up today as well.

I also would like to thank the Department of City Planning Director Marisa Lago and General Counsel Anita Laremont for their collaboration on this legislation.

I wanna thank our Land Use staff for really tremendous work, probably a thousand plus hours working on this, including our Land Use Director Raju Mann; Assistant Director Amy Levitan; General Counsel Julie Lubin; and Counsel Jeff Campagna.

I also wanna thank in my own office my
Counsel Elena Sytcheva, who is the point person on
this and my Chief of Staff Danny Pearlstein, for
working with me to get this done; it's a wonderful
achievement -- 3.2 million square feet of public
