3	everyone. I'm Council Member Robert Cornegy, Chair
4	of the [background comments, pause] Good afternoon
5	everyone. I'm Council Member Robert Cornegy, Chair
6	of the Committee on Housing and Buildings, and I'm
7	joined today by Council Members Espinal, Perkins,
8	Grodenchik, Rosenthal and Rivera. We're here to hold
9	a vote on several bills that seek to reduce the
10	amount of fires and improve fire safety. These bills
11	were heard jointly with the Committee on Fire and
12	Emergency Management in February. The first bill
13	Proposed Intro 602-A sponsored by Council Member
14	Borelli will require that all doors and residential
15	occupancies be self-closing by July 34 th -31 st , 2021,
16	and creates an HPD violation in connection with
17	failure to keep and maintain self-closing doors. The
18	second bill Proposed Intro 604-A sponsored by myself
19	will require that where a smoke alarm or detector is
20	within an area of 20 feet from a statue-stationary or
21	fixed cooking appliance in all residential buildings
22	after January 1, 2021 that smoke alarms must be
23	listed in accordance with standards for reduction of
24	nuisance alarms. The third bill sponsored by Council
25	Member Richards would require the Fire Department in

2	consultation with the Office of Emergency Management
3	and the Mayor's Office for People with Disabilities
4	to develop a checklist to assist individuals with
5	disabilities or limited mobility in developing
6	individualized emergency evacuation plans. The
7	fourth bill sponsored by Council Member Torres would
8	require building owners to provide stove knob covers
9	to tenants in units where children under the age of
10	six reside. Today is just a vote. We also-today is
11	just a vote. Billy Martin, would you call the roll.
