Be it enacted by the Council as follows:

Section 1. The title and subdivisions a and b of section 19-128 of the administrative code of the city of New York, as added by local law number 49 for the year 2007, are amended to read as follows:

§ 19-128. Damaged or missing signs <u>and signals</u>. a. For the purposes of this section, the [phrase] <u>following terms shall be defined as follows:</u>

(i) "priority regulatory sign" shall mean a stop sign, yield sign, do not enter sign, or one way sign[.];

(ii) "traffic control signal" shall have the same meaning as set forth in section one hundred fifty-four of the vehicle and traffic law or any successor provision thereto.

b. The department shall maintain a log of notices regarding priority regulatory signs <u>and traffic control</u> <u>signals</u> that are missing or damaged to the extent that any such sign <u>or signal</u> is not <u>operational</u>, visible or legible to a motorist who must obey or rely upon such sign <u>or signal</u>. Such log shall include the date and time such notice was received and the date and time on which such priority regulatory sign [or one way sign] <u>or</u> <u>traffic control signal</u> was repaired or replaced, or the date on which a determination was made that repair or replacement was not warranted and the reason for such determination.

§ 2. Section 19-128 of the administrative code of the city of New York is amended by adding two new subdivisions e and f to read as follows:

e. Within twenty-four hours of receiving notice that a traffic control signal is missing or damaged to the extent that such signal is not operational or visible to a motorist who must obey or rely upon such signal the department shall:

(i) repair or replace such signal,

(ii)implement alternative measures to control traffic if such repair or replacement will take greater than twenty-four hours, or

(iii) make a determination that repair or replacement is not warranted.

f. This section shall not apply with regard to traffic control signals at a location where multiple traffic

## control signals are present and facing the same direction in the same intersection and one or more of such

## signals remains operational.

§ 3. This local law shall take effect ninety days after its enactment into law.
