A Local Law in relation to requiring a study on the impact of growth in the taxicab and for-hire vehicle industries

File #: Int 0847-2015, Version: A

Be it enacted by the Council as follows:

Section 1. The taxicab and limousine commission, in collaboration with other relevant city agencies including, but not limited to, the department of transportation and the department of environmental protection, shall complete a study regarding the impact of growth in the taxicab, street hail livery, for-hire vehicle, black car, and luxury limousine industries on traffic, air quality, noise, and public health. Such study shall consider, at a minimum, the following factors: i) the number of driver's licenses issued and renewed within the previous three years; ii) the number of driver's licenses eligible for renewal that were not renewed within the previous three years; iii) the number of vehicle licenses issued and renewed within the previous three years; v) the number of vehicle licenses, black car base licenses, and luxury limousine service in each borough within the previous three years; to the extent such information is available. No later than April 30, 2016, such study shall be submitted to the speaker of the council and posted on the commission's official website.

§ 2. This local law takes effect immediately.
