WHEREAS, the Landmarks Preservation Commission filed with the Council on May 21, 2015 a copy of its designation dated May 12, 2015 (the "Designation"), of the Bank of the Manhattan Company Building, Long Island City, located at 27-29 Queens Plaza North (aka 29-27 41st Avenue, 29-39 Northern Boulevard), Community District 1, Borough of Queens, as a landmark and Tax Map Block 403, Lot 9, formerly part of Lot 21, as its landmark site pursuant to Section 3020 of the New York City Charter;
