WHEREAS, the New York City School Construction Authority submitted to the Council on August 4, 2015, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 240-Seat Pre-Kindergarten School Facility to be located on the north side of 93<sup>rd</sup> Street between 3<sup>rd</sup> and 4<sup>th</sup> Avenues (Block 6103, Lots 42 and 43) in the Bay Ridge section of Brooklyn, Community District No. 10, Borough of Brooklyn, serving pre-kindergarten students in Community School District No. 20 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on August 11, 2015;

WHEREAS, the Council has considered the relevant environmental issues, including the Negative Declaration issued on August 3, 2015, (SEQR Project Number 16-002) (the "Negative Declaration"); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the
