A Local Law to amend the administrative code of the city of New York, in relation to the retirement of black cars

Be it enacted by the Council as follows:

File #: Int 1092-2016, Version: A

Section 1. Chapter 5 of title 19 of the administrative code of the city of New York is amended by

adding a new section 19-544 to read as follows:

§ 19-544 Vehicle retirement. No black car shall be subject to retirement from service so long as such

vehicle passes all inspections required pursuant to the vehicle and traffic law, this code, or any rules

promulgated by the commission.

§ 2. This local law takes effect immediately.
