Section 1. Paragraph (i) of subdivision b of section 11-244 of the administrative code of the city of New York, as amended by local law number 56 for the year 2007, is amended to read as follows:

(i) the eligible improvements are commenced after July first, nineteen hundred eighty, and prior
to December thirty-first, two thousand [eleven] <u>nineteen</u>, and are completed within thirty-six months from
commencement;

§ 2. This local law takes effect immediately.
