**Whereas,** Bills have been introduced in the New York State Legislature by Senator Golden, S.8015, and Committee on Rules (at request of Assembly Member Abbate), A.10567, "AN ACT to amend the retirement and social security law, in relation to disability benefits for certain members of the New York city fire department pension fund; and to amend the administrative code of the city of New York, in relation to the powers, duties and responsibilities of the board of trustees of the New York city fire department pension fund, and in relation to authorizing such board of trustees to draw upon the assets of such fund to pay expenses";
