WHEREAS, the Department of Consumer Affairs filed with the Council on June 28, 2016 its approval dated June 23, 2016 of the petition of BK BT Venture, LLC, d/b/a Black Tree BK, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 261 Metropolitan Avenue, Community District 1, Borough of Brooklyn (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
