**Resolution approving a motion to file pursuant to withdrawal of the application for a revocable consent for an unenclosed sidewalk café located at 261 Metropolitan Avenue, Borough of Brooklyn (20165568 TCK; L.U. No. 425).**

#### By Council Members Greenfield and Richards

WHEREAS, the Department of Consumer Affairs filed with the Council on June 28, 2016 its approval dated June 23, 2016 of the petition of BK BT Venture, LLC, d/b/a Black Tree BK, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 261 Metropolitan Avenue, Community District 1, Borough of Brooklyn (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226 (g) of the Administrative Code;

WHEREAS, by letter dated August 8, 2016, and submitted to the City Council on August 8, 2016, the Applicant withdrew the Application submitted to the Department of Consumer Affairs for recommendation for approval for the revocable consent.
