Be it enacted by the Council as follows:

Section 1. Section 3-703 of the administrative code of the city of New York is amended by adding a new

subdivision 17 to read as follows:

17. Notwithstanding any other law or rule, at any time before or after receiving public funds,

participating candidates may return a contribution because of the particular source or intermediary involved,

provided that if matching funds were received for such contribution then such matching funds shall be returned

to the board.

§ 2. This local law takes effect immediately.
