## Resolution affirming the designation by the Landmarks Preservation Commission of 18 East 41<sup>st</sup> Street (a/k/a 18-20 East 41<sup>st</sup> Street) (Tax Map Block 1275, Lot 61), Borough of Manhattan, Designation List No. 490, LP-2581 (Preconsidered L.U. No. 557; 20175170 HKM; N 170169 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on December 2, 2016 a copy of its designation dated November 22, 2016 (the "Designation"), of 18 East 41<sup>st</sup> Street (a/k/a 18-20 East 41<sup>st</sup> Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 1275, Lot 61, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the New York City Planning Commission submitted to the Council on January 20, 2017, its report on the Designation dated January 18, 2017 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 24, 2017; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
