A Local Law in relation to reporting on the improper use of city-issued parking permits

File #: Int 0314-2018, Version: A

Be it enacted by the Council as follows:

Section 1. Improper use of city-issued parking permits. a. Definitions. For purposes of this section, the

term "city-issued parking permit" means a permit issued by a city agency that indicates permission to park in

certain areas during certain times has been granted.

b. No later than June 30, 2020, and every six months thereafter within 30 days of December 31 and June

30, the police department shall submit to the council a report on the improper use of city-issued parking permits

during the preceding six months. Such report shall include, but need not be limited to, information on the

number of summonses the department issued in connection with the improper use of city-issued parking

permits, disaggregated by the section of the New York city traffic rules that was violated.

§ 2. This local law takes effect immediately and is deemed repealed February 1, 2024.
