WHEREAS, the Department of Consumer Affairs filed with the Council on June 22, 2018 its approval dated June 20, 2018 of the petition of 235 East 4<sup>th</sup> Inc., d/b/a Nobody Is Perfect, for a new revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 235 East 4<sup>th</sup> Street, Community District 3, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(f) of the Administrative Code;

WHEREAS, by letter dated August 1, 2018 and submitted to the City Council on August 1, 2018, the Applicant withdrew the Application submitted to the New York City Department of Consumer Affairs for recommendation for the approval for the revocable consent.
