WHEREAS, the Department of Consumer Affairs filed with the Council on June 22, 2018 its approval dated June 20, 2018 of the petition of 235 East 4<sup>th</sup> Inc., d/b/a Nobody Is Perfect, for a new revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 235 East 4<sup>th</sup> Street, Community District 3, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
