Be it enacted by the Council as follows:

Section 1. Chapter 1 of title 15 of the administrative code of the city of New York is amended by adding

a new section 15-139 to read as follows:

§ 15-139 Online applications for fire alarm plan examinations and inspections. a. The department shall

make all components of applications for fire alarm plan examinations available for online submission.

b. The department shall make all components of applications for fire alarm inspections available for

online submission.

§ 2. Subdivision a of section 15-139 of the administrative code of the city of New York, as added by

section 1 of this local law, takes effect 180 days after it becomes law, and subdivision b of section 15-139 of the

administrative code of the city of New York, as added by section 1 of this local law, takes effect 1 year after it

becomes law, except that the fire department may take such measures prior to such date as are necessary for

implementation of this local law, including the promulgation of rules.
