**Whereas**, bills have been introduced in the New York State Legislature by Senators Golden, Maltese, Marchi, Mendez, Padavan and Velella, S.4186-A, and Assembly Member Abbate, A.7163-A, "AN ACT to amend the administrative code of the city of New York, in relation to loans to members of the New York city fire department pension fund"; and

**Whereas**, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
