**State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senators Golden, Maltese, Marchi, Mendez and Padavan, S.4186-B, and Assembly Member Abbate, A.7163-B, "AN ACT to amend the administrative code of the city of New York, in relation to loans to members of the New York city fire department pension fund".**

**Whereas**, bills have been introduced in the New York State Legislature by Senators Golden, Maltese, Marchi, Mendez and Padavan, S.4186-B, and Assembly Member Abbate, A.7163-B, "AN ACT to amend the administrative code of the city of New York, in relation to loans to members of the New York city fire department pension fund"; and

**Whereas**, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it

**Resolved**, that the Council of the City of New York, in accordance with the provisions of Section 2 of Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bills.
