| 3 | for all New York City residents regardless of age, |
| 4 | gender, identity, national origin, or citizenship |
| 5 | status. It provides a host of benefits to cardholders |
| 6 | and functions as an official form of identification |
| 7 | in New York City. It is accepted by city agencies to |
| 8 | access services and programs, can be used as a |
| 9 | library card, and used to open a bank or credit union |
| 10 | account with participating financial institutions. |
| 11 | Ensuring this card is available to all New York |
| 12 | residents is necessary, and this bill aids in |
| 13 | ensuring it is available. |
| 14 | Preconsidered Resolution 714-A, also sponsored by |
| 15 | Council Member Shahana Hanif, calls on the New York |
| 16 | State Legislature to reintroduce and pass, and the |
| 17 | Governor to sign A.3506/S.2235, also known as the New |
| 18 | York for All Act, which would prohibit and regulate |
| 19 | the discovery and disclosure of immigration status by |
| 20 | New York state and local government entities. |
| 21 | Resolution 717, sponsored by Council Member |
| 22 | Crystal Hudson, calls on the New York State |
| 23 | Legislature to pass and the Governor to sign |
| 24 | A.270/S.141, also known as the Access to |
| 25 | Representation Act, which establishes the right to |

1 COMMITTEE ON IMMIGRATION 6 legal counsel in immigration court proceedings and 2 3 provides for the administration thereof. These bills, all of which I have co-sponsored, 4 call to improve protections and resources for our 5 immigrant communities. 6 7 The Trump administration has made it abundantly clear that they will do everything in their power to 8 9 detain, deport, undocumented immigrants which would be devastating for the over 470,000 immigrants in New 10 11 York City- who do not have immigrant legal status-12 and have lived and worked and built our city for 13 many, many years and those who are part of mixedstatus families. 14 15 As the Trump administration's xenophobic agenda 16 continues to close any pathway to citizenship, our 17 immigrant communities are becoming increasingly vulnerable to detention, deportation actions from the 18 19 federal government. 20 The rhetoric from the Trump administration painting undocumented immigrants as criminals is 21 overwhelmingly disturbing, irresponsible, horrible-2.2 23 I can't think of- so many words I can say- and attempts to let those inhumane characterizations sway 24
