Proposed Intro No. / Title: *Int. 1451/ A Local Law to amend the administrative code of the city of New York, in relation to requiring the New York city police department to provide the civilian complaint review board with direct access to officer body-worn camera footage and to establish related procedures*

Summary of Legislation: This bill would require the New York City Police Department (NYPD) to provide the Civilian Complaint Review Board (CCRB) with direct access to all footage recorded by officers' body-worn cameras. This access would provide designated CCRB employees with real time connectivity to network servers hosting the digital files of body-worn camera footage, and permit such employees to search, view, and use files for the purpose of investigating and prosecuting allegations of police misconduct.

Effective Date: 90 days after becoming Law

Impact on Expense:

It is anticipated that the NYPD would require \$2,492,046 in annual Personal Service (PS) cost (excluding fringe) to create a unit consisting of 35 personnel to manage approximately 50 million historical records (as of 11/14/25), as well as 1.2 million new records that are added each month.

There is \$10 million in immediate Other Than Personnel Service (OTPS) software development costs to ensure compliance with state privacy laws and access parameters.

The itemized expense costs are an estimation based on the current understanding of the requirements of this legislation.
