*\*\*Editor's Note re: Attendance for the Stated Meeting held on May 29, 2019 and the brief Recessed Meeting held on June 13, 2019: This Recessed Meeting held on June 13, 2019 is considered to be the continuation and conclusion of the Stated Meeting which opened on May 29, 2019. For attendance purposes, therefore, any Council Member who was present at any one of these two Meetings will be considered present for all of the proceedings known collectively as the Stated Meeting of May 29, 2019. Although Council Members Borelli, Brannan, Espinal, Eugene, Gibson, Grodenchik, King, Lancman, Matteo, Powers, Rodriguez, Salamanca, Torres, Treyger, Ulrich and Van Bramer were marked absent for this Recessed Meeting held on June 13, 2019, these same Council Members are considered present but not voting for these brief June 13th proceedings due to their presence at the earlier Stated Meeting held on May 29, 2019. Council Member Moya is still considered absent since he was not marked present at either the Stated Meeting held on May 29, 2019 nor at these brief Recessed Meeting held on June 13, 2019.*

*Editor's Local Law Note: Int. Nos. 944-A, 1053-A, 1056-B, 1138-A, 1150-A, 1157-B, 1167-A, 1169-A, 1199-A, 1427, and 1445-A., all adopted at the April 9, 2019 Stated Meeting, were returned unsigned by the Mayor on May 9, 2019. These items become law on May 10, 2019 due to the lack of Mayoral action within the Charter-prescribed thirty day time period. These bills were assigned subsequently as Local Laws Nos. 81 through 91 of 2019, respectively,*

*Int. Nos. 276-A, 1031-A, 1032-A, 1251-A, 1252-A, 1253-C, 1317-A, 1318-A, and Preconsidered Int. No. 1527, all adopted at the April 18, 2019 Stated Meeting, were returned unsigned by the Mayor on May 20, 2019. These items had become law on May 19, 2019 due to the lack of Mayoral action within the Charter-prescribed thirty day time period. These bills were assigned subsequently as Local Laws Nos. 92 through 100 of 2019, respectively,*
