**Summary of Legislation:** This legislation codifies the city's cooling center program and updates definitions for heat vulnerability index and heat-related emergency. It additionally requires the Department of Health and Mental Hygiene (DOHMH), in consultation with the New York City Emergency Management Department (NYCEM), to conduct a public education and outreach campaign on heat-related emergencies. It also requires DOHMH and NYCEM to report annually on cooling centers.
