**Proposed Intro No. 1201/ Title:** *Access to gender-affirming care facilities and a cause of action related to interference with gender-affirming care*

**Sponsors:** Hanif, Bottcher, Rivera, Ossé, Restler, Hudson, Nurse, De La Rosa, (in conjunction with the Brooklyn Borough President)

**Committee:** Women and Gender Equity

**Summary of Legislation:** Amends Chapter 10 of title 10 of the Administrative code to replace all instances of "reproductive health care" with "care related to bodily autonomy" and amends Chapter 22 of Title 17 to replace "reproductive or endocrine health care" with "care related to bodily autonomy". Additionally, the legislation increases the civil action statutory damages for denied care related to bodily autonomy to \$10,000.

**Effective Date:** Immediately upon enactment
