16 Today, the Committee will hear and vote on two 17 resolutions:

Proposed Resolution Number 720-A, which I have sponsored, calling on the New York State Legislature to pass, and the Governor to sign, A.50/S.1077, sponsored by Assemblymember Robert Carroll and State Senator Julia Salazar, known as the New York City Arts Space Act, to promote the development of affordable arts spaces in New York City.

2	We will also hear Resolution Number 792,
3	sponsored by Council Members Tiffany Cabán and Amanda
4	Farías, declaring March 25 as Greek Cultural
5	Appreciation and Independence Day annually to honor
6	both the perseverance of the Greek people in their
7	own fight for freedom and their integral place in the
8	culture and history of the City of New York.
9	Now, I would like to invite Council Member Cabán
10	to provide remarks on Resolution Number 792.
11	Council Member?
12	COUNCIL MEMBER CABÁN: Thank you very much, Chair.
13	Today, I'm proud that this Resolution is being
14	heard, alongside, Majority Leader, Amanda Farías,
15	declaring March 25th Cultural Greek Cultural
16	Appreciation and Independence Day.
17	This Resolution honors Greeks Greece's fight
18	for independence and the enormous impact Greek
19	immigrants and Greek Americans have had in our city.
20	Since the turn of the twentieth century, many
21	thousands of Greek immigrants have made their way to
22	New York City, and a significant number of them have
23	found a home in the heart of my district, Astoria.
24	Today, about 70,000 Greek New Yorkers are crucial
25	members of our city.

COMMITTEE ON CULTURAL AFFAIRS, LIBRARIES AND 1 INTERNATIONAL INTERGROUP RELATIONS 5 2 March 25 is the day on which the Greek people 3 celebrate the Greek revolution of 1821 and greet each other by saying, "Hronia polla" (phonetic), which 4 means live many years. 5 Today, we recognize the Greek community in my 6 7 district, the deep bond between Greece and The United States, and the social and cultural contributions of 8 9 Greek Americans in New York City. So, Hronia polla, and thank you very much. Thanks, Chair. 10 11 CHAIRPERSON RIVERA: Thank you, Council Member. And a few words on my Resolution Number 720, this 12 13 Resolution expresses the Council's support for the 14 State Legislatures New York City Arts Space Act which 15 would extend property tax benefits to building owners and developers for the creation of long-term, 16 17 affordable artist work spaces in commercial buildings 18 being converted for residential use. This is just one 19 way we can help increase access to affordable arts 20 spaces, that can be rented or leased by nonprofit 21 arts organizations as studios, rehearsal spaces, or 2.2 performance spaces, or as spaces for producing arts 23 and cultural programming open to the public. I have heard loud and clear from organizations 24

and workers in the cultural sector that rising rents

Arts organizations have been in survival mode for far too long, struggling to stay 4 afloat as market forces and inadequate support make 5 it increasingly difficult for artists and cultural 6 7 workers to build sustainable careers. 8 The New York State Arts Space Act would help 9 bolster one of our greatest assets and ensure that New York can remain a place where artists can thrive. 10 11 I would like to thank my staff as well as Committee staff, who worked on preparing this 12 13 legislation: Katie Loeb, my Chief of Staff, Eddie 14 Amador, Director of Legislation, Christina Yellamaty, 15 the Committee's counsel, Regina Paul, the Committee's 16 Policy Analyst, who also drafted the Resolution, and 17 Sandra Gray, the Committee's Financial Analyst. 18 Is there anyone here who would like to give 19 public testimony on the Record?
