23 to Section 105 of the New York State Public Officers'  
24 Law.

2 COUNCIL MEMBER AYALA: Aye.

4 COUNCIL MEMBER DINOWITZ: Aye.

5 COUNCIL MEMBER HUDSON: Aye.

6 CHAIRPERSON UNG: Noting that the ayes  
7 have it, I am now going to close this portion of the  
8 meeting and reopen Executive Session.

9 I ask all Committee Staff to clear the  
10 room. I also ask the Sergeant-at-Arms to stop taping  
11 this portion of the meeting.

12 If Executive Session results in a

14 not return. We will simply let the Sergeant-at-Arms  
15 know that we are not returning.

17 we will return to regular session to report the vote  
18 when Executive Session concludes.
