Dear City Council members of the Subcommittee on Landmarks, Public Sitings and Dispositions:

My name is Melissa Barber. As a South Bronx native, a voting constituent of Council District 8, and president of the Mott Haven-Port Morris Community Land Steward community land trust, I testify in favor of the NYC Health & Hospital Corporation leasing the former Lincoln Recovery Center to the Mott Haven-Port Morris Community Land Stewards, Inc. to create the HEArts Community Center. This holistic community center, which will focus on the three pillars of health, education, and the arts will be a crucial addition to the uplifting and vitality of this community. The HEArts Center, which will not only provide a home for many of the amazing non-profit CBOs in the neighborhood that are currently undergoing and/or facing displacement due to gentrification and high rents, the center will foster an environment where holistic health methodologies and artistic expression will help to provide wellness and wholeness in a neighborhood, which has long been neglected and overlooked.

Over thirteen years ago, the founding members of our community land trust conducted community envisioning sessions to hear the voices of our community. We asked them to dare to dream and tell us what they

accumulated over \$10 M in damages. All of the community's desires for the space encompassed the three pillars, health, education, and the arts, which drive our mission for the center.

Since that time, we have carried the voices of the community, progressively putting actions to their ideas and ultimately, having learned that the answers and solutions to heal our community will mainly come from within. Our goal of bringing this holistic community center into fruition was something bigger than us. However, in faith, we took progressive steps to create a plan that included obtaining feasibility studies, asking elected officials to help us obtain the land and give supportive funding, making connections and collaborations with developers and academic institutions to further the progress of our mission, applying for grants and other funding to support the work, and growing our board and membership base.

Now, thirteen years later, at this pivotal moment, we are seeking an approval from this committee to release this land and lease it to us in order to bring the community's dream into fruition. Will you do it? We, the community land trust members and staff, have jumped through every hurdle presented to us; we have outlasted several elected officials and many times had to start over again with each new elected; we have campaigned and have raised most of the funding required to bring this \$43M project into fruition. Please help us to hold true to our promise/commitment to carry the voices of our community and once again help to heal it.
