CHAIRPERSON LOUIS: [GAVEL] Good afternoon everyone, my name is Farrah Louis, and I'm the Chair of the Committee on Women and Gender Equity.

Today, the Committee will vote on the following pieces of legislation. Intro. 691-A sponsored by myself amending the Administrative Code of the City of New York in relation to the annual reporting on racial and gender disparities in STEM education for high school students; Proposed Intro. 1297-A sponsored by Council Member Brooks-Powers amending the Administrative Code of the City of New York in relation to reopening the look-back window to the victims of Gender-Motivated Violence Protection Law; Proposed Intro. 1216-A sponsored by Council

First, I would like to acknowledge my

Gutiérrez, and Riley's on his way.

on this day, I am proud to be the lead sponsor of Intro. 691-A. The equal participation and leadership of women and girls in science, technology, engineering, and math, also known as STEM, is more important than ever. Yet the numbers tell a stark story. Women comprise only 28 percent of the global STEM workforce, and these disparities are even more pronounced when we examine race and ethnicity alongside gender. As we enter a transformative era defined by artificial intelligence and technological advancement, we cannot afford to leave half of our talent on the sidelines. We need more women in STEM to drive innovation through diverse perspectives, inclusive products and solutions, and to close the

2	persistent gender pay gap that limits economic
3	mobility across our city. Intro. 691 requires the
4	Department of Education to conduct annual surveys of
5	high school students, particularly those in career
6	and technology education programs, also known as
7	CTEs, to assess and report on racial and gender
8	disparities in STEM education participation. High
9	school is the critical gateway to STEM careers, and
10	this data-driven approach will also allow us to
11	identify barriers, measure progress, and implement
12	targeted interventions where they're needed the most.
13	By surveying our students, we can understand who is
14	participating, who's being left out, and why. In a
15	city as diverse, innovative, and forward-thinking as
16	New York, we have both an opportunity and an
17	obligation to lead on gender equity in STEM. When
18	women are included in STEM fields, we see more
19	creative problem solving, better designed
20	technologies that serve a wider population, and a
21	more robust competitive and equitable economy. The
22	future of science and innovation depends on who gets

to participate. Let's make sure it includes everyone.

I urge my Colleagues to vote in favor of 691 and all of the following bills on today's calendar.

We've also been joined by Council Member Vernikov, Brooks-Powers, and Riley.

And now I would like to invite sponsor of Intro. 1297, Council Member Brooks-Powers to provide remarks.

COUNCIL MEMBER BROOKS-POWERS: Thank you and good morning. I would like to begin by thanking you, Chair Louis, for your commitment ensuring this legislation receives the thoughtful and urgent consideration it deserves.

Intro. 1297 restores what was always the intent of the Gender-Motivated Violence Act, that survivors should have a meaningful path to justice, not only against individual abusers, but also against the institutions that enabled harm. After a recent court ruling narrowed the law, hundreds of survivor cases were suddenly placed at risk. That cannot be allowed to stand. The testimony we heard in October made it made clear what is at stake. Survivors were harmed in places meant to protect them. Juvenile facilities, hospitals, schools. Their cases deserve

2	to be heard, not dismissed on a technicality. This
3	bill reopens the look-back window, clarifies
4	institutional liability, and ensures survivors are
5	not pushed back into the shadows. I thank Chair Louis
6	and all of my Colleagues who have stood with
7	survivors. I look forward to bringing this to a full
8	Council for a vote, and I urge my Colleagues to
9	support this bill. Thank you.
10	CHAIRPERSON LOUIS: Thank you.

12	and the Members of the Women and Gender Equity
13	Committee Staff, Senior Committee Counsel Julia
