Committee: Contracts

Summary of Legislation: The proposed legislation would require the establishment of a public online database to contain information from all stages of the contracting process for every mayoral agency procurement that exceeds the small purchase limits. The database must be free and reusable to the public and include information regarding procurement requirements including rationale, evaluation methodology, contract terms, funding information, award description, and reporting requirements.

Effective Date: 120 days after enactment
