**Proposed Intro No. / Title:** Int. 1242-A / Establishing a coordinator for Rikers Island closure and a coordinator for borough-based jail transition

Sponsors: Nurse, Louis, and Rivera

**Committee:** Criminal Justice

Summary of Legislation: This legislation would require the mayor to establish an Office for Coordination of the Transition to Borough-Based Jails. The mayor shall additionally establish an interagency working group to provide recommendations regarding the transition to borough-based jails. No later than May 1, 2026, the working group shall submit a strategic planning report containing such recommendations and shall also submit quarterly progress reports thereafter. The legislation additionally establishes a department coordinator for borough-based jail transition within the Department of Correction. By May 1, 2026, the coordinator shall submit a report detailing any recommendations for reforms relating to staffing and jail security, as well as any operational reforms to improve conditions for departmental staff and persons in custody. By November 1, 2026, the coordinator shall submit a staffing report for each jail on Rikers Island which shall include uniformed and civilian staff needed to operate each type of housing unit in such jail. No later than August 1, 2027, or when practicable, the coordinator shall submit a similar staffing report for each jail not located on Rikers Island.
