Summary of Legislation: This legislation establishes eligibility standards for supportive housing wholly financed using city funds and stipulates that time spent confined in a New York City or New York State jail or residential mental health facility constitutes homelessness so long as the person was homeless prior to entering and is expected to be homeless upon exiting such facility. It further establishes that any confinement in such a facility for more than one year constitutes homelessness for eligibility purposes.
