2 SERGEANT-AT-ARMS: Good afternoon. This is
3 a microphone check for the Committee on Standards and
4 Ethics. Today's date is December 2nd, 2025, located
5 in Hearing Room 3, recording done by Pedro Lugo.

6 SERGEANT-AT-ARMS: Good afternoon, welcome
7 to the New York City Council Hearing on the Committee
8 on Standards and Ethics.

20 necessary for the Committee to discuss confidential
21 personnel matters. Therefore, I'm making a motion for
22 the Committee to move into Executive Section pursuant
23 to Section 105 of the New York State Public Officers'
24 Law. All those in favor, say aye.

25 DEPUTY SPEAKER AYALA: Aye.

2 COUNCIL MEMBER CARR: Aye.

3 COUNCIL MEMBER DINOWITZ: Aye.

4 COUNCIL MEMBER HUDSON: Aye.

5 CHAIRPERSON UNG: Noting that the ayes
6 have it, I am now going to close this portion of the
7 meeting and reopen in the Executive Session.

8 I ask all, except Committee Staff, to
9 clear the room. I also ask the Sergeant-at-Arms to
10 stop taping this portion of the meeting.

11 If the Executive Session results in a
12 decision to consider further and reconvene, we will
13 not return. We will simply let the Sergeant-at-Arms
14 know we are not returning.

15 If the Executive Session results in a
16 vote, we will return to regular session to report the
17 vote when the Executive Session concludes.

18 I'm going to ask the Sergeant-at-Arms to
19 turn off all recording equipment. Thank you.
