**Summary of Legislation:** This legislation requires that the Department of Health and Mental Hygiene (DOHMH) shall conduct an annual outreach campaign to inform parents and legal guardians about their rights in relation to childcare programs. DOHMH must make campaign materials available to childcare services, home-based childcare programs, and pediatric health care providers throughout the city. Such campaign materials must contain information on how to make complaints to relevant governmental entities, the rights of parents and guardians to have access to their children while in childcare, and a description of the informational notices that childcare providers and programs must display. Childcare providers and programs are required to provide these materials to the parents and guardians of children enrolled.

**Effective Date:** 4 Months after enactment
