SERGEANT AT ARMS: Good morning and welcome to today's New York City Council vote for the Committee on Health. At this time, I would like to remind everyone to silence all electronic devices. Also, no one is to approach the dais. Chair Schulman, we are ready to begin.

CHAIRPERSON SCHULMAN: Okay, thank you.

Alright, I'm starting the meeting. I don't have a-good morning. I am Council Member Lynn Schulman, Chair of the New York City Council's Committee on Health. Thank you for joining us on today's vote on my bill, Introduction 1390 in relation to cooling tower inspection and testing. Before I begin, I'd like to recognize that we've been joined by Council Members Zhuang, Ariola, Marmorato, Menin, and on Zoom, Narcisse, Gennaro, and Feliz. Today, we will vote on a bill that strengthens New York City's requirements for testing and maintaining cooling towers, an important measure to protect public health and prevent future outbreaks of Legionnaire's This legislation comes at a critical time, disease. following the recent outbreak that reminded us how dangerous and fast-spreading Legionella bacteria can be when proper precautions are not taken or ignored

completely. This bill would require building owners
to test their cooling towers for the presence of
harmful microbes at least once a month during the
months when the towers are in use. All testing must
be done by or under the supervision of a qualified
professional to ensure accuracy and compliance. The
bill also mandates that building owner perform a
biocide treatment, a process that kills harmful
bacteria during warm weather when the Department of
Health and Mental Hygiene determines that the risk of
Legionella growth is highest. In addition, this
legislation renews critical reporting requirements
for the Department of Health and Mental Hygiene. The
Department will continue to report on cooling tower
registrations, inspections, testing, and
certifications, as well as on reported diagnoses of
Legionnaire's disease. These reports help us track
progress, identify risks early, and hold both the
public and private sectors accountable for
maintaining safe conditions. The recent Harlem
outbreak underscores that our work to prevent
Legionnaire's disease is not done. Every case is
preventable and every delay in testing or treatment
nuts lives at risk By undating regulations and

2	strengthening oversight, we're ensuring that building
3	owners stay vigilant, that the City can act swiftly
4	and that all New Yorkers no matter what borough they
5	live in are protected from this deadly preventable
6	illness. I would like to thank my staff, the
7	administration, as well as committee staff for their
8	hard work on this bill. Clerk, we are ready to begin
