Summary of Legislation: This bill makes changes to the composition of the Street Vendor Advisory Board to include the Commissioner of Veterans' Services (DVS). This bill also increases the number of members that the speaker can appoint from six to seven. The additional member that the speaker appoints must be someone who represents the veteran community. DVS must also post information on its website related to supporting veterans who are general vendors.
