Summary of Legislation: Requires that the Mayor designate an agency to coordinate a public education program on legal rights and resources for transgender, gender nonconforming, nonbinary, and intersex (TGNCNBI) individuals. Such educational program should include right to access gender-affirming care, locations to receive gender-affirming care, a list of community-based organizations which provide services for TGNCNBI individuals, process for legal name change, and any other rights for TGNCNBI individuals.

Effective Date: 90 days after enactment
