Summary of Legislation: This legislation requires the Department of Health and Mental Hygiene (DOHMH) to ensure the newborn home visiting program is available to 75 percent of priority neighborhoods within 3 years of the effective date, and all such neighborhoods within 5 years of the effective date. DOHMH additionally must submit an intermediate progress report 3 years after the effective date and a final progress report 5 years after the effective date.
