2 SERGEANT-AT-ARMS: This is a microphone
3 check for the Committee on Criminal Justice recorded
4 on December 18, 2025, located in Hearing Room 1 by
5 Nazly Paytuvi.

6 SERGEANT-AT-ARMS: Good morning, and
7 welcome to today's New York City Council vote for the
8 Committee on Criminal Justice.

9 At this time, please silence all
10 electronic devices and no one may approach the dais
11 at any time.

12 Chair, we are ready to begin.

13 CHAIRPERSON NURSE: [GAVEL] Good morning.
14 I'm Council Member Sandy Nurse, Chair of the
15 Council's Committee on Criminal Justice. I'd like to
16 welcome you to our vote on Proposed Resolution Number
17 734-A.

18 I want to recognize my Colleagues,
19 Council Member Brewer, Ayala, Cabán, Abreu, and
20 Marte.

21 To keep people in custody safe, an
22 effective and independent oversight of the state
23 prison system is imperative. The horrific death of
24 Robert Brooks and Messiah Nantwi, both allegedly
25 killed by correction officers in State prisons,

2 underscores the need to strengthen transparency,
3 accountability, and oversight across the Department
4 of Corrections and Community Supervision.

5 I am now going to turn it over to Council
6 Member Gale Brewer to give remarks on her bill.

7 COUNCIL MEMBER BREWER: Thank you very
8 much, Chair Nurse, and this is Resolution 734, which
9 as you heard, calls on the State Legislature to pass,
10 I think it has, and the Governor to sign Prison
11 Safety is a Public Safety Robert Brooks Transparency
12 and Accountability Legislative Package. And why this
13 is important, I think is very specifically is that we
14 need, after the horror of Mr. Brooks' murder by
15 correction officers, we need to have a bill that does
16 the following, and this is somewhat what this does.
17 It would include investigators, monitors, public
18 oversight, disciplinary processes within the State
19 Department of Corrections. It would have authority to
20 review policies and practices. It would place
21 authority to terminate employees squarely under their
22 purview, and it is introduced particularly by, and I
23 want to thank her, Senator Julia Salazar, who led the
24 effort to pass the State legislation. So I'm here, I
25 think just like everyone else, to say that there's a

2 lot of broken situations on the State prisons, and we
3 heard a group from those who are either formerly
4 incarcerated or who have friends and family earlier
5 today about the need for this bill. So hopefully
6 Resolution Number 734-A will talk about the need to
7 do that. I want to thank particularly the Marshall
8 Project, the Correctional Association, and others who
9 have made this bill possible. Thank you very much,
10 Madam Chair.

11 CHAIRPERSON NURSE: Thank you, Council
12 Member Brewer.
