Summary of Legislation: This legislation would require the Mayor's Office of Immigrant Affairs (MOIA) to create signage outlining the legal protections enacted in sections 4-210, 10-178, 21-977, and 23-1202 of NYC Administrative Code and listing the rights individuals may invoke when interacting with federal immigration authorities. MOIA shall provide the signage to agencies so it may be displayed in a central location in every agency building. MOIA is also responsible for conducting outreach on the information contained in the signage and shall report on its efforts.
