Summary of Legislation: This bill would create a private right of action against the Department of Probation, the Department of Correction, and the New York Police Department, for cooperating with federal immigration authorities or supporting actions taken on civil immigration detainees, including for failure to intervene federal authorities. The legislation includes parameters on damages to be sought by persons filing such private rights of action.

Effective Date: 60 days after enactment
