SERGEANT-AT-ARMS: Good morning. This is a microphone check for the Committee on Parks and Recreation. Today's date is December 4, 2025, located in Hearing Room 2, recording done by Pedro Lugo.

SERGEANT-AT-ARMS: Good morning, and welcome to today's New York City Council vote on the Committee on Parks and Recreation.

At this time, please silence all cell phones.

Chair, you may begin.

CHAIRPERSON KRISHNAN: [GAVEL] Good morning. I'm Shekar Krishnan, Chair of the Council's Committee on Parks and Recreation.

Today, we will conduct a vote on four bills and a resolution. Intros 988, 1058, 1059, and Reso. 469 derived from multiple hearings this Committee held last year relating to how we can vastly improve water safety and prevent drownings at the City's beaches and pools.

Proposed Intro. Number 988 would require the Parks Department to create an online map that provides up-to-date information for swimming pools under its jurisdiction, including the location, contact information, events, programs, and any

planned maintenance projects that could impact the
pool's accessibility.

Proposed Intro. Number 1058 would require

Parks to consult with the DOE to conduct a

feasibility study on how high school students could

be trained with the goals of preparing them to become

lifequards at City-managed beaches and pools.

Intro. 1059 would require the Parks

Department to develop written education materials

about water safety and drowning prevention and

provide them to DOE for distribution to every student

at the beginning and end of the academic year.

The last bill of the water safety package, Reso. 469, recognizes May 15th as
International Water Safety Day, which brings awareness to the epidemic of drowning and educates children and adults about how they can become safer in, on, and around the water. One drowning death is too many. We must do everything we can to ensure that children in our communities have the education resources they need to stay safe. We have the responsibility to make swimming safer and more accessible for everybody.

The last bill we are conducting a vote on is Proposed Intro. Number 1425-A, sponsored by my Colleague, Council Member Susan Zhuang, and first heard last week on November 24th before this Committee. It would require the Parks Department to submit a quarterly report on the staffing levels of Parks Enforcement Patrol, or PEP, officers and park rangers, as well as the incidents responded to by PEP officers and rangers at City parks for the previous quarter.

As Chair of the Committee on Parks and Recreation, I take the safety of our neighbors and our parks very seriously, and I'm proud to support legislation that brings more transparency that's needed to keep our parks safe. We need clearer and more accurate information on where PEP officers are delayed to ensure that every New Yorker is safe and enjoying our beautiful City parks.

I thank everyone who worked on developing these pieces of legislation, and I urge all of my Colleagues on this Committee to vote in favor of them.
